This report relates to the deployment of the above officers as oracle 23 at the above event. After a briefing at NSY we were given reference cards dated 20/07/2004 of possible subjects who may attend to protest at this event. We were ground assigned at 17.30hrs and made discreet enquiries at the hotel reception of possible activists booked in to the hotel in an attempt to side step security, as in previous occasions. This showed that none of the names given were booked in as guests.

We then proceeded on foot to MARBLE ARCH tube station to monitor the exit for any subjects or possible protestors arriving. We remained in the vicinity of MARBLE ARCH until about 18.30 hrs. We were then made aware that Emily APPLE, [redacted], Jason BISHOP, [redacted], [redacted] were among a group of 10 protestors who had made their way to the venue via HYDE PARK. They were shepherded into a cordoned area outside the venue. They were very subdued and not very vocal. We were aware that all those persons within the pen were searched under sect PACE for articles concerned in criminal damage. This resulted in the arrests of Emily APPLE and [redacted] who had clothes soaked in red dye, with the believed intention of committing criminal damage. [redacted] and APPLE resented their arrest and were also arrested for public order offences. Also in the vicinity was [redacted] who was wearing a BLACK T SHIRT with a WHITE SKULL & CROSS BONES with ST PAULS written below it. HE was wearing spectacles and on his push bike. He was handing out leaflets to dinner delegates and shouting abuse at them regarding selling weapons of death and misery. He was spoken to and was fairly good-natured and said he was not intending to stay long as they

hadn't been a big response from people.

We then monitored [REDACTED] and Jason BISHOP as they walked to 01CD to await the release of APPLE and [REDACTED]. They stopped off to buy them sweets and newspapers, which they handed to the SRO at 01CD. As they waited outside [REDACTED], and another female who was outside the hotel joined them. She was wearing BLACK top CRIMSON trousers and GREEN dyed hair beneath a BLACK HEADSCARF. [REDACTED] and this female were both on pushbikes.

We left them all outside the police station and returned to NSY for a full de brief at 21.45 hrs.
