

This report relates to the 'STOP THE WAR COALITION' demonstration 10/11/2004. The following known WOMBLES were seen and dealt with by Officers 11 in various situations described.

1. Emily APPLE - FEMALE IC1 with distinctive dark red hair wearing a Burgundy scarf around her head, black jacket.
2. [REDACTED] - MALE IC1 F601 stocky build, dark cropped hair wearing a black jacket, black jeans white trainers.
3. [REDACTED] - FEMALE IC1 with long brown hair, dark glasses wearing a black fleece, black combats with ribbons on.
4. [REDACTED] - MALE IC1 with a small beard and moustache, glasses wearing a light coloured fleece and a yellow bandana around his neck.
5. [REDACTED] - MALE

At 1750 hours APPLE, [REDACTED] were seen walking south in WHITEHALL SW1.
On being seen [REDACTED] & APPLE ran off across the traffic into PARLIAMENT SQUARE SW1.
All four were observed in the crowd listening to the speakers.
[REDACTED] placed a yellow bandana across his face to hide his features.
Prior to being photographed [REDACTED] & APPLE were then lost in the crowd.
[REDACTED] were photographed by MAGNET 14.
[REDACTED] was then followed off into WHITEHALL SW1 at 1830 hours.
[REDACTED] then entered 'THE LORD MOON OF THE MALL' PH WHITEHALL SW1.

Already inside were [REDACTED] & APPLE drinking at a table.

Police stood at the door and [REDACTED] said "FUCK OFF" towards them. The pub was packed with other customers. At 1845 hours [REDACTED] was w ed under Sec 5 POA 1986. He replied " I only mouthed it "

At 1855 hours [REDACTED] left the pub via the back door whilst [REDACTED] & APPLE slipped out the back.

[REDACTED] went back to PARLIAMENT SQUARE SW1 before returning to 'THE LORD MOON OF THE MALL ' PH.

At 2040 hours there were reports of disturbances in PICADILLY & LEICESTER SQ. Not attended by ORACLE 11.

[REDACTED] was again seen leaving the pub and was followed all around PICADILLY and LEICESTER SQUARE. He led us to a group of approx 12 others including [REDACTED] & APPLE who were waiting in GOODWINS COURT WC2. On seeing FITS officers the group ran off at speed. They were followed and eventually split up and scattered in BEDFORDBURY STREET WC2.

[REDACTED] was again followed this time he decided to try and out run us. Eventually he gave in in WHITEHALL and returned to the 'THE LORD MOON OF THE MALL'

At 2100 hours other officers spotted a group of protesters blocking the traffic in TRAFALGAR SQUARE SW1.

[REDACTED] was moved from the road using no more force than necessary to remove the obstruction and allow traffic to flow.

Present in the group was [REDACTED]. He was seen squaring up to Level 2 officers moving them from the road. He was then seen to enter 'THE LORD MOON OF THE MALL' PH. His identity was confirmed by PC DISCOMBE C011.
